Scholarship Application

INSTRUCTIONS

It is the policy of Issaquah Parks & Recreation to make program opportunities available to youth, regardless of a family's income. We provide scholarships to those who might not otherwise be able to participate. Scholarships may be granted for the entire class fee less the \$10 registration fee or we may provide a percentage discount, depending on individual circumstances. All information will remain confidential.

To be eligible for a scholarship you must have a youth (under 18 years) residing in the Issaquah School District and meet the household size/yearly income requirements.

Applicants meeting the eligibility guidelines are awarded up to \$600 per family per calendar year. Eligible residents will be **required to provide proof of residence and income for entire household**. Household is defined as: those on the IRS Income Tax Return and/or all individuals living in your home that you care for (married or not).

Submit only **copies** of your documents and **attach them to the completed application**. Copies **will not be returned or retained**.

Examples of supporting documents You only need **one** of each category:

• Income verification with name on it

Tax return, W-2's for all income earners in the household 21 and Older King County Housing Authority 'Rent Calculation Worksheet' Social Security Income Applicant is a Foster Child DSHS Approval letter with current eligibility amounts

Proof of living within the Issaquah/Issaquah School District Boundaries

Supporting documents must have the name and address of service location on them. Water, sewer, garbage bills PSE gas/electric bill Lease agreement or Mortgage paperwork

Scholarship applications must be approved prior to registration

A scholarship application alone does not register the participant, nor does it reserve space in a program. Registrations are processed in the order received. You will be notified once your application for scholarship has been reviewed.

Exclusions

Scholarships are not applicable for: birthday parties, adult leagues, partnered service providers, contracted camps, or specialty programs, and adult passes.
